Copyright policy

If your manuscript is published in MRA, you and your co-authors reserve the right to publish and reproduce the unrevised manuscript in whole or in part at any time and in any form for any scholarly non-commercial purpose with the condition that all publications of the manuscript include a full citation to the journal as published by MRA.

Refund policy and miscellaneous terms

After a manuscript is accepted, and all necessary edits are made and uploaded to the journal's website by the author(s), and all publication fees are paid, MRA has 40 days to publish the manuscript on its website. If MRA fails to publish the accepted manuscript within 40 days, the author is entitled to a full refund of all fees, unless the author has notified MRA that they do not want the manuscript to be published.

If MRA fails to complete the peer-review process for a manuscript within 40 days of completion of the submission process, the author is entitled cancel this agreement.

In all other circumstances publication fees are non-refundable. The journal may issue a full or partial refund of fees paid at its discretion and on a case by case basis.

The publication fee is due within 15 days of acceptance of the submitted manuscript. After 15 days the journal may charge a late fee equal to 5% of the publication fee. If the publication fee for an accepted manuscript has not been paid MRA has no obligation to publish the manuscript. If the publication fee is not paid within 20 days after acceptance of the manuscript, or within 60 days of the estimated submission date stated in this agreement, or if the author files a chargeback for a paid publication fee, MRA may un-publish the manuscript if it has been published, and has the right to obtain payment of the publication fee by invoicing co-authors of the manuscript, or by charging the author's payment card or bank account information on file, or by any other lawful means. By selecting the electronic payment option and entering your payment details you authorize MRA to charge your card or bank account for the publication fee immediately upon acceptance of your manuscript.

If at any time after the payment of the publication fee and publication of a manuscript, the payment is reversed, via a chargeback or other means, MRA reserves the right to immediately un-publish the manuscript until all fees are returned.

MRA may in some instances choose to publish a manuscript with unpaid publication fees.

In the event that a publication fee is paid for a manuscript that has not yet been submitted, the author is entitled to publish any one manuscript with MRA for 1 year from the date of payment, after peer-review and acceptance of the manuscript.

If at any time an author wishes to withdraw their published manuscript they must notify MRA in writing. MRA must un-publish the manuscript from its website within 5 business days of receiving such notice.
